## **Conditions of Entry and Use**

## Welcome to Chapel Off Chapel

Your entry to Chapel Off Chapel located at 12 Little Chapel Street, is subject to these terms and conditions of entry.

## Summary

## Safety and conduct

- Abusive, disruptive, racist, discriminatory and threatening behaviour or language will not be tolerated toward any employees, patrons or artists on site at any time.
- You must take reasonable care for your own safety and the safety of any children in your care. We
  will follow our procedures in the event of any accident or incident. If this requires us to call for
  medical assistance, including an ambulance, you will be responsible for all associated costs.
- Children who are under 15 years of age must be under the care and active supervision of a person who is deemed a responsible adult as per LCV guidelines.
- All persons entering the facility must not engage in any form of child abuse or harm towards, against, with or in the presence of a child, or threaten to engage in such conduct. Stonnington Council reserves the right to remove any person from the facility if their behaviour deemed dangerous or unacceptable.
- Smoking, vaping and illicit drugs are prohibited in the Venue.
- If you breach these conditions, you will be directed to immediately leave the Venue. We may also require you not to return to the Venue for a period of time or at all.
- We reserve the right to call law enforcement agencies when necessary, as per the Liquor Control Victoria enforcement guidelines.
